- (g) The secretary with the consent of the chairman and on requisition of any one trustee, may convene a meeting of the board of trust. At least one meeting of the board of trustees shall be held every year.
- (h) At least 1/3rd trustees present in person shall form the quorum for any meeting.
- (i) If, at any meeting of the board of trustees, the chairman is not present the vice chairman will preside and if both are not present the trustees present shall choose one of them to be the chairman of such meeting.
- (j) All questions arising at a meeting of the trustees shall be decided by a majority of votes, and in case of equality of votes, the chairman shall have a second or casting vote.
- (k) A resolution in writing circulated amongst all the trustees and passed by a majority of the trustees, shall be valid and effective





- (s) The trustees may purchase, construct, alter, lease, on rent partly or fully immovable or movable property from time to time.

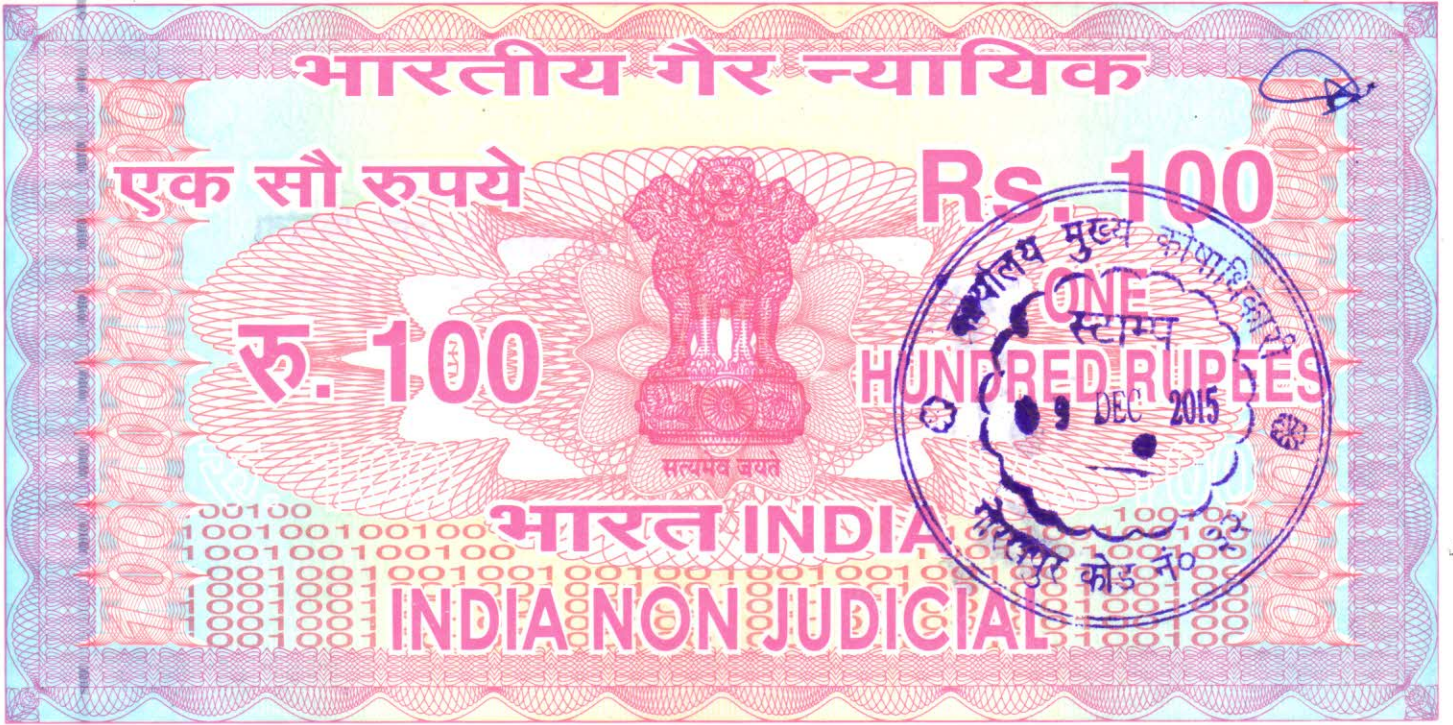

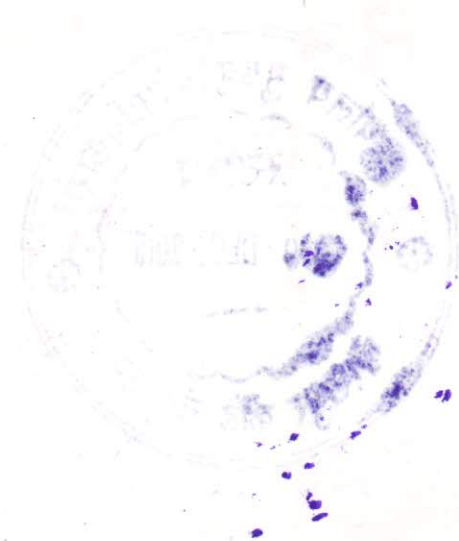
The trustees shall maintain proper accounts. They will be annually audited by a Chartered Accountant appointed by the board of trustees, fixing his remuneration.
